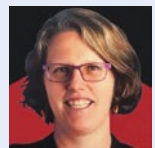

SAN FRANCISCO BALLOT MEASURES

A MUNI Reliability & Street Safety Bond

YES *We like improving our public transit!*

B Building Inspection Commission

YES *Create a Department of Sanitation and Streets to focus on street cleanliness while establishing an oversight committee to ensure taxpayer money is spent ethically.*

C Recall Timelines & Vacancy Process

HELL YES! *Recalls have been used in our city by national conservatives and billionaire elites to undermine the democratic process.*

D Victims & Witness Rights

H District Attorney Recall

HELL NO!! *Chesa Boudin has been fulfilling his campaign promises: holding police officers accountable, breaking the cycle of crime by addressing root causes, stopping the prosecution of children as adults, ending the use of cash bail which criminalizes poverty, dedicating resources to address hate crimes and increasing language access for Asian victims, and creating an Economic Crimes Unit to protect workers rights. Nationally, an attempt to undermine criminal justice system reform has poured millions into this recall and attempted recalls across the country.*



SF PUBLIC HOUSING FOR ALL

Most of us can't afford to live in San Francisco, let alone buy a home. The private for-profit sector has completely failed to provide us with affordable, well-maintained homes. We need to create a system that guarantees housing as a human right. We demand Public Housing for All.

Our organization has worked to pass SF **Propositions I and K** in November 2020, which taxed large real-estate transactions and authorized 10,000 units of Public Housing for All. Since then, we've fought Mayor London Breed to get funding allocated and won against her last November. We now have to get the City to take this task seriously, and create a scalable fully-public system of "Housing for the 99%."
